EMERGING TECHNOLOGIES - ROBOTIC PROCESS AUTOMATION (RPA) - Available Fall 2020

This highly interactive one-day course is designed for organizations and individuals who seek a better understanding of Robotic Process Automation. Students will learn the basic concepts, the vocabulary, the benefits, and the impacts. Real life examples of federal implementations demonstrate how RPA changes how work gets done.

JOINT TRAVEL REGULATIONS WORKSHOP: TDY | COURSE 5081

Participants will learn the current rules and regulations for temporary duty (TDY) travel for uniformed members, civilian employees, and other personnel traveling under orders from the Department of Defense (DoD). The rules for and use of per diem allowances, lodging, international travel, actual expense allowances for high cost areas, and more will be addressed.

DECISION SUPPORT USING MANAGERIAL COST ACCOUNTING | COURSE 5092

This course focuses on the basics of federal cost accounting. It emphasizes applying the requirements of the Statement of Federal Financial Accounting Standards (SFFAS) No. 4: Managerial Cost Accounting Standards.

This course is designed for those who need to support decision-making about allocating federal resources, authorizing and modifying programs, and evaluating program performance. Program managers may also use cost information when making managerial decisions to improve operating economy and efficiency. This course does not use debit and credit entries, although a familiarity with financial record keeping and reporting will be helpful.

OVERVIEW OF GAO REQUIREMENTS FOR FRAUD PREVENTION, ENTERPRISE RISK MANAGEMENT AND INTERNAL CONTROL | COURSE 5892

This course is intended for Mid to Senior level managers. Course participants will understand how to develop more effective ERM systems which improve the current internal control environment across an organization's programs, operations, and acquisitions. Participants will understand how effective internal control impacts accountability of programs, the resolution of material weaknesses, and auditability of financial statements. Participants will be exposed to the complexities of developing an effective enterprise-wide risk assessment; a critical component in the achievement of mission success. Issues surrounding improper payments and identifying waste, fraud and abuse of federal resources, including the GAO Fraud Risk Management framework are also discussed.

MANAGING FOR SUCCESS IN A PERFORMANCE AUDIT | COURSE 5320

Performance auditors conduct complex audits, provide recommendations to improve processes, and support decision-making through data analysis. It is critical for both auditors and auditees to gain insight into how effective performance audits are performed with such varied responsibilities. Course participants will learn to develop an audit-focused mentality when establishing a new program and planning for audits after an overview of auditing basics. Participants will also use analytical techniques to meet organizational expectations and respond to challenges in the Federal environment.
